

Data protection

Information about data protection at Ernst Möschle Behälterbau GmbH, Kinzigtalstrasse 1a , 77799 Ortenberg, Germany for the website www.moeschle.com.

We take the protection of your personal details very seriously. In the following section, we hope to briefly explain what details are recorded as you use www.moeschle.com and what we do with these details. Basically we believe that the protection of privacy is of great importance. It is therefore only natural for us to comply with the legal provisions on data protection. Above and beyond this we believe it is important for you to know whenever we store details and what we do with them.

What are personal details?

Personal details are all the information regarding the personal and factual circumstances of a particular or definable person. This includes information and details such as your (correct) name, home address or other postal address and phone number. This also includes your e-mail address if it is related to your name such that you can be identified by it. This does not include information which cannot be used to establish your identity. Examples of such details include: all details which make no reference to your name, e.g. simply your height, whether you are male or female, your age, education or income.

When and why are your personal details collected and stored?

When you access www.moeschle.com the following details of your visit are stored on our server for the purpose of data security: IP address of the computer which requested the page, time, status, volume of data transferred and web page from which the user accessed the page requested (referrer), product and version information of the browser used (user agent) and screen resolution. The details of your visit are assessed for statistical purposes only. We can use them for example to find out on which days and at what times there is a particular demand for the site and what volume of data is produced at that time. The details can also be used to find potential errors, such as incorrect links or program errors. We do not make any link between the details of a visit and individuals.

Our usage of said details only extends beyond that described above if you expressly agree to such use.

Personal details are never disseminated.

Your personal details are not disseminated to third parties unless you have expressly agreed to this or we are obliged to do so, for example due to an instruction from a court or official body.

Collection and processing of user information

We collect information on how our site is used from individual computers. This information is however stored separately and makes no reference to personal details.

We collect such information in order to pursue two goals. Firstly we want to provide users of our websites with tailored online offers featuring content and services of relevance and interest to them. Secondly this allows us to offer more individual (but not individualised) content both from an editorial and advertising standpoint and therefore to also raise the personal usefulness of the site for you. Your privacy remains protected at all times because the information does not allow the user's individual identity to be inferred.

You are entitled to request information on the details stored under your log-in name at any time. You are also entitled to object at any time to the creation of a user profile with effect for the future (for address, see below).

Counting page hits

We use Google Analytics, a web analysis service provided by Google Inc. ("Google"). This analysis service uses "cookies", text

files which are saved on a user's computer and make it technically possible for website use to be analysed. The information about use of this website created by the cookie (including the IP address) are sometimes transferred to servers in the USA and stored there. This information is used to produce reports on website activities on www.moeschle.com and to provide other services linked to usage of the website and Internet. Google will also disseminate this information to third parties if necessary provided that this is prescribed by law or provided that the third parties process this data on behalf of Google. The analysis tool operator will never make the link between the IP address and other personal details.

Cookies

When you visit our website, we and some partners use what are known as cookies, i.e. small text files saved on the user's computer, for the "Autologin" function which "recognises" a member and automatically logs him or her in when he or she returns to the page. You can prevent these cookies from being saved at any time in your browser and delete any cookies present.

Information and right of objection

You can request information about the details stored for your person or for the pseudonym assigned to you at any time. The details shall be provided immediately and at no charge. We reserve the right to provide this information electronically.

In the event of a request for information or an objection you will need to provide sufficient details to allow us to individualise the data we hold (at least name and e-mail address) and valid evidence that this information relates to you.
